#### **Welcome & Introductions**

Dr. Chris Cogle began by welcoming all members and guests, and also briefly reviewing the day's agenda. Each Council member, guest, and participants on the phone took a moment to introduce themselves to the room. Also, Dr. Cogle recognized departing members, Rep. Matt Hudson and Sen. Eleanor Sobel, and introduced Dr. Jahanzeb Mohammad as the new representative of the Sylvester Comprehensive Cancer Center at the University of Miami.

## **Approval of Minutes**

Dr. Cogle led the motion to review and approve the meeting minutes from the April 29, 2016 meeting. After hearing no motions to amend the minutes, Dr. Clement Gwede and Dr. Robert Cassell motioned to approve the minutes. The Council concurred.

## **Cancer Plan Progress & Dashboard Review**

Goal 1 – The Faces of Cancer in Florida: Burden of Cancer

Goal 2 – Best Defense is a Great Offense

Dr. Cogle began by reviewing the Council's mission: Advise the Florida Legislature, Florida Surgeon General, and Governor of Florida on ways to reduce Florida's cancer burden. Dr. Cogel then reviewed cancer incidences and mortality rates in Florida, emerging technologies in cancer, and highlights of the cancer plan. (Please see attached Power Point Presentation.)

Following the introductory slides, Dr. Cogle outlined the 5 goals, 15 objectives, and 153 working tasks that are identified in the Cancer Plan and detailed in the Dashboard. The task for the Council on this day will be to initiate conversation on items that are either in progress, complete, or in complete.

The Council then began inserting notes regarding the progress, or lack there of, on each work task, within the 15 objectives - under each of the 5 goals.

Surgeon General Update: *Dr. Celeste Philip* BRAC: Update & Research Plan: *Dr. Daniel Armstrong* The Council conducted at working lunch. Dr. Celeste Philip, Florida's Surgeon General, and Dr. Daniel Armstrong, Chair of BRAC – Florida Biomedical Research Advisory Council, provided the Council with updates.

Dr. Philip began by outlining a health and wellness dashboard that the department is currently working on which would include the following areas: overarching risk factors, health disparities, community level engagement for addressing the aforementioned risk factors, engaging local leadership, and identifying political champions. Dr. Philip referenced the best means by which these areas could be addressed would be by viewing them through a health equity lens and how they are applicable areas of evidence based research. Additionally, Dr. Philip touched on the upcoming efforts of the Telehealth Advisory Council (tasked by the Florida legislature to provide a report to appropriate bodies by October 31, 2017), the work the Council had conducted over the summer with FCDS, and a palliative care taskforce update.

Dr. Armstrong reviewed the open call for King and Bankhead-Coley, and said that he believes that the Biomedical Research Trust Fund will have the same available funding as last FY. Additionally, the BRAC has increased the number of respondents from previously funded PI's. Dr. Armstrong further pressed the degree of overlap and connectivity between CCRAB and BRAC, and why the two Council's

partnership and cohesiveness is critical to mutual success. When asked about the number of applicants the BRAC reviewed, Dr. Armstrong responded by saying that the number was similar to last year.
